Kurzbeschreibung

Das Seminar untersucht Fragen der Ethnizität, ethnischen Identität sowie ethnischer Konflikte und Demokratie in nicht-westlichen Ländern. Ziel ist es, eine fundierte Wissensbasis zu Ethnizität und ethnischen Konflikten in unterschiedlichen Regionen zu erarbeiten. Der Kurs soll Studenten mit dem theoretischen Rüstzeug und empirischen Fachwissen zur Analyse von Fragen der Ethnizität und ethnischer Konflikte in multiplen Länderkontexten vertraut machen.

Der Kurs ist in drei Themenfelder gegliedert (1) die Natur von Ethnizität; (2) Charakter und Ursachen ethnischer Konflikte, (3) Lösung ethnischer Konflikte. Die wöchentlich zu bearbeitende Lektüre für den Kurs basiert auf einem ausgewogenen Mix von theoretischen Ansätzen und Fallstudien und erstreckt sich auf Konflikte in vier Weltregionen: Afrika, Mittlerer Osten, Asien und Osteuropa. Der Kurs betont substantielles Lesen, intensives Schreiben, sorgfältige Analyse, systematische Auswertung, Training der konzeptionellen Fähigkeiten, kritisches Denken, sowie Diskussionsfähigkeit. Neben Präsentationen und Diskussionsgruppen werden, soweit möglich, Film- und Tondokumente in den Seminarverlauf eingearbeitet.
