## Seminarplan

### "Internationaler Terrorismus" Di. 11.00 - 13.00 Uhr, Neue Uni HS 15

#### Kurzbeschreibung

Das Seminar bietet einen breiten Überblick zum Forschungsfeld Terrorismus und beschäftigt sich vertiefend mit Beispielen des internationalen Terrorismus. Der Kurs ist in drei Teile gegliedert: Im ersten Drittel erkunden wir allgemeine Fragen des Themas – Terrorismus und andere Formen der Insurgenz und des politischen Extremismus, die Struktur terroristischer Gruppen, die Motivation von Terroristen, Autoritäts- und Entscheidungsstrukturen in terroristischen Organisationen sowie der Einfluss unterschiedlicher Operationstypen auf Regierungen und Öffentlichkeiten. Im zweiten Teil werden wir uns tiefergehend mit einigen ausgewählten terroristischen Kampagnen beschäftigen (u.a. sozialrevolutionärer Terrorismus in Argentinien, Ethnoterrorismus der IRA, Rechtsterrorismus in den USA, religiöser Terrorismus in Japan u.a.O.). Im dritten Teil beschäftigen wir uns mit dem so genannten „neuen Terrorismus“, dessen Archetyp Al Qaeda ist. Darüber hinaus betont der Kurs substantielles Lesen, intensives Schreiben, sorgfältige Analyse, systematische Auswertung, Training der konzeptionellen Fähigkeiten, kritisches Denken, sowie Diskussionsfähigkeit. Am Ende des Semesters findet ein zusätzliches Blockseminar statt. Der genaue Termin und der Ort werden zu Semesterbeginn bekannt gegeben.
