Heidelberg University Tuition Fee Regulations for the Master's Degree Programme in International Health

as of 03/01/2011

In accordance with §§ 2 paragraph 2 and 13 paragraph 1 of the State Higher Education Fees Act (Landeshochschulgebührengesetz) from 1 January 2005 (Law bulletin of Baden-Württemberg [GBI.] pg. 1, 56 et seqq.), last amended in article 7 of the Act from 3 December 2008 (GBI. pg. 435, 457), in connection with § 19 paragraph 1 item 10 of the State Higher Education Act from 1 January 2005 (GBI. pg. 1 et seqq.), last amended in article 1 of the law for the improvement of both university access for professionals and university admissions (Gesetz zur Verbesserung des Hochschulzugangs beruflich Qualifizierter und der Hochschulzulassung) from 15 June 2010 (GBI. pg. 422 et seqq.), the senate of Heidelberg University passed the following regulations on 14/12/2010.

Approved by the President on 03/01/2011.

§ 1 Applicability

Heidelberg University charges tuition fees for the Master's degree programme in International Health. In accordance with § 12 of the State Higher Education Fees Act, the administrative fee, as well as fees related to the Student Services Act (Studentenwerksgesetz) remain unaffected.

§ 2 Tuition Fee Amount

- (1) For the one-year residential programme, tuition fees amounting to 7,050 euros are charged per semester.
- (2) Students in the European strand of the programme, who have chosen Heidelberg University as their home university, will be charged tuition fees amounting to 7,863 euros for the core module, the final thesis and the semester in which examinations are taken.

§ 3 Obligation to Pay

Anyone applying for immatriculation in the Master's degree programme is obliged to pay the tuition fee.

§ 4 Due Date for Payment

Tuition fees are due to be paid upon notification, provided that an alternative due date for payment is not stated therein.

§ 5 Waiver

The tuition fee may be completely or partially waived if demand of payment of the tuition fee is, in individual cases, deemed unreasonable. The final decision as to whether an application for a waiver is approved shall be made by the governing committee of the Institute of Public Health.

§ 6 Coming into force

This Charter becomes effective one day after it is published in the President's Bulletin
